- i. Agency may be a Company established under Section 8 of the Companies Act(1956/2013) or a Registered Trust or a Registered Society, established by Central Government or State Government or any entity established under an Act of Parliament or a State Legislature.
 - ii. Agency other than those specified above, such company or trust or society shall have an established good track record of at least three years in undertaking similar projects.
 - iii. Agency must be having GST registration and / or having a valid certificate under Section 12AA of the Income tax Act, 1961
