PRCL also reserves the right to reject any Tender/quotation/offer or whole of the process of disposal/ scrap sale at any time, without assigning any reason. Each page of documents should be signed by the tenderer(s) in token of acceptance of terms and condition of Tender/quotation/offer. Incomplete and/or unsigned Tender/quotation/offer is liable to be rejected. conditional quotes/ offer shall not be accepted.
- 2. Tenderer/bidder hereby declares that he/she/it is not debarred by law enforced in India from buying above outlived vehicles of PRCL.
- 3. Tenderer may inspect the vehicles on all working days (from Monday to Friday between 09:30 hours to 18:00 hrs.) at respective offices of Senior Section Engineer (P. Way), Railway as under:

- 4. The vehicle(s) shall be sold to the highest quoting tenderer and the bids will be accepted of only those firms/individuals who quote the price in proper columns of Annexure-II. No item, once disposed to the successful tenderer, shall be taken back by PRCL.
- 5. The successful tenderer has to make the full payment in the form of Demand Draft from any Nationalized Bank drawn in favour of "Pipavav Railway Corporation Limited" payable at "New Delhi" or any mode of electronic payment within 03 (Three) bank working days, after confirmation by PRCL of acceptation of the offer, failing which the offer may be cancelled and EMD shall stand forfeited.

- 6. The EMD of the successful tenderer will be returned after full payment of contract is received and all terms and conditions of the tender are fulfilled.
- 7. The EMD deposit shall not attract any interest.
- 8. The successful tenderer shall be required to pick up the vehicle(s) from site at its own cost within 3 (three) days after the full payment to PRCL of the accepted quoted/ offered price amount. On failure to do so, PRCL shall have the right to forfeit the entire amount of the tenderer and shall be free to make disposal of the vehicle to the second highest tenderer. PRCL shall not be responsible for safety of the vehicle during this period.
- 9. An affidavit regarding proper disposal/scraping of the vehicle from the First-Class Magistrate shall have to be given, before taking possession of the vehicles.
- 10. The vehicle identification plate (the one that has the engine and chassis numbers engraved on it, successful tenderer might need someone to use a blowtorch and cut it out from surrounding metal) shall be removed and handed over to the PRCL/Railways' competent authority before taking away the vehicle.
- 11. The tenderer shall not be allowed to withdraw their bids. If doing so, the EMD will be forfeited.
- 12. Final decision to accept / reject the bids shall be of the PRCL Competent Authority, New Delhi.
- 13. Bid shall be submitted in the prescribed format (Annexure II) in a sealed envelope with Annexure I, Tender Fee, EMD, Self-Attested legal documents of Address Proof, PAN and Aadhar Card of the tenderer.
