

## NOTICE INVITING TENDER

Sealed tenders are invited from Scrap Dealers, Individuals and others who are interested in buying scrap of GI Sheets & other iron items laying at Pipavav Station, Rampara – 2, Taluka: Rajula, District – Amreli. The details are as summarized below: -

1	Name of Scrap Item	GI Sheets
2	Procedure for quoting price	The offer price shall be quoted for <b>PER TONNE</b> “as is where is basis”. The tender shall be awarded based on the highest offer received. Quoted rates must be inclusive of all taxes, transportation, loading/ unloading, labour charges etc. 100% advance payment to be made to Pipavav Railway Corporation Limited before lifting the scrap.
3	Earnest Money Deposit along with tender	Bidder shall submit the EMD of <b>Rs. 5,000/-</b> in form of DD in favor of Pipavav Railway Corporation Limited, payable at New Delhi.
4	Cost of Tender Documents	Bidder shall submit the non-refundable Tender Fee of <b>Rs. 500/- plus 18% GST</b> in form of DD in favor of Pipavav Railway Corporation Limited, payable at New Delhi.

**INSTRUCTION TO THE TENDERERS**

1. The Tender shall be submitted in accordance with the instructions and any tender not complying with the instructions, as under is liable to be rejected. These instructions shall form part of the tender and contract.
2. The tender should be submitted in sealed cover super-scribed as “Tender for Sale of Scrap”.
3. The cost of Tender Document i.e Rs. 500/- (Rupees Five Hundred only) plus 18% GST and EMD i.e. Rs. 5,000/- should be enclosed with the Tender by way of Demand Draft/Pay Order or any mode of online payment in favour of “Pipavav Railway Corporation Limited” payable at New Delhi.
4. The tender shall be completed in all respect and should be signed with date by the Authorized Signatory of Tenderer on all the pages.
5. The offer price shall be quoted for the scrap per TONNE basis “AS IS WHERE IS BASIS” including GST, transportation, loading/ unloading, labour charges etc.
6. The Tenderers are free to inspect the Scrap at Pipavav Railway Station, Village Rampara-2, Taluka – Rajula, District – Amreli on any working days from w.e.f. 30/04/2026 to 14/04/2026 up to 12:00 Hrs. in the presence of PRCL’ representatives (**Sh. Arvind Pathak – Mobile No. 97240 97693, Sh. Suresh Kumar, Sr. Assistant – Mobile No. 97240 97695**)
7. The tender shall be awarded based on the highest offer received for GI Sheet and other Iron scrap. Upon award of the contract, the particular highest bidder shall deposit full amount by way of Demand Draft/Pay Order in favour of “**Pipavav Railway Corporation Limited**” payable at **New Delhi** of the scrap item within 7 days. And deposited EMD with tender will be kept as Security Deposit which shall be returned to the party without any interest upon successful completion of the lifting of the items or within 60 days whichever is earlier.
8. It may be noted that the quantity as mentioned in tender shall be considered as approximate quantity but the actual payment would be calculated on the basis of actual quantity of scrap to be lifted. In case the actual quantity is above the quantity mentioned in tender, then the balance amount has to be paid through **PRCL’ QR Code Scanner** or any mode online payment and if less the quantity mentioned above tender, then the balance amount will be returned by PRCL with Security Deposit in form of NEFT/RTGS in account of tenderer as per details provided in Technical Bid.
9. The truck/tempo for Scrap lifting and carrying shall be arranged by tenderer at their own cost. The tenderer shall have to make arrangement for loading of scrap to truck/ tempo at their own cost and PRCL will not pay any charges for the same.
10. Prior to the loading of scrap on the Truck/Tempo, the empty Truck/Tempo shall be taken to the Weighing Bridge for weighing in presence of representative from PRCL.
11. The loaded truck would again be sent to the weighing scale for weighing, and the weight of material would be calculated for payment of quantity of scrap based on the quoted price. The Weighing Bridge will be decided at random by PRCL representative and the weighing bridge charges (if any) shall be borne by the H1 bidder.
12. All process of disposal of scrap material including weighment shall be in presence of authorized / nominated representative of PRCL, who shall certify to the effect of completion of such process of scrap sale.
13. Photo/videography of the site before and after completion of scrap shall be taken.

## COMMERCIAL AND GENERAL TERMS & CONDITIONS

Sealed Tenders are hereby invited for disposal of GI Sheet and other iron Scrap “AS IS WHERE IS BASIS”.

The Scrap is available for disposal at the above address of PRCL – Pipavav Railway Station as per the following terms & conditions:

1. Tenderers shall submit their offer in a sealed cover super scribed as “Tender for Sale of Scrap” to PRCL’ Pipavav & Bhavnagar office on or before 14/05/2026 up to 15.00 Hrs.
2. Tenderers shall take into account the cost of labour, loading & cartage etc. for taking delivery from the premises of PRCL before quoting the rates. In this regard no claim what so ever shall be entertained by the PRCL. PRCL shall hand over the scrap to successful tenderers on the place & conditions where it is actually lying presently in the Campus.
3. The successful Tenderer shall bear the cost of weighing the empty & loaded Truck/Tempo.
4. PRCL representative shall accompany the Truck/Tempo arranged by the successful tenderer for weighing. The weighing bridge selected by PRCL representative for weighing the empty/loaded truck/tempo shall be binding on the Tenderer. The empty Truck/Tempo shall be directly brought to the PRCL after weighing.
5. PRCL, reserves all the rights to accept or reject any or all the offers. The decision of the PRCL will be final and binding on the Tenderers.
6. The bids of the tenders will be opened on 18/05/2026 at 11:00 Hrs. The Tenderers or their authorized representatives (One person only) may be present at the time of opening of the tender.
7. The successful Tenderers shall pay quoted amount in Rupees as detailed in PARA 7 of “INSTRUCTION TO THE TENDERERS” by way of Demand Draft/Pay Order in favor of “Pipavav Railway Corporation Limited” payable at New Delhi towards the cost of Scrap within 03 (three) working days from the date of awarding the order. If tenderer failed to deposit quoted amount in stipulated times, offer will be rejected and EMD will be forfeited by PRCL. It may be noted that the quantity as mentioned against scrap in tenderer shall be treated as approximate quantity but the actual payment would be made by tenderers on the basis of actual weight of scrap to be lifted.
8. All responsibility related to labour P.F., ESI, Insurance etc. or any taxes as applicable will be of the successful Tenderers. PRCL shall not be responsible for the same.
9. The scrap is being sold on “AS IS WHERE IS BASIS”. The scrap is being sold on the assumption that the Tenderers have inspected them and know what they are buying and the principles of “CAVEATEMPTOR” shall apply and no reliance must be placed on any description of the scrap.
10. All the communication shall be addressed to: Sr. Manager (M&L), PRCL Office, Behind of DRM Office, Bhavnagar Para, Bhavnagar – 364003 (Gujarat)
11. In the event of any dispute the legal matter shall be subjected to the jurisdiction of New Delhi Court only.
12. Applicable taxes / TCS shall also be payable by tenderers on the sale value of scrap.
