

CORPORATE SOCIAL RESPONSIBILITY (CSR)

As a responsible Corporate, PRCL has formulated a CSR Policy and is contributing for the development of Society.

Effective FY 2014-15, Company has formulated a CSR Policy and an amount of ₹1.38 crore has been earmarked for CSR activities.

1. Contribution towards following activities has been made and completed: -
 - ✓ Computer systems for Railway School at Bhavnagar, at a cost of ₹3 lakhs
 - ✓ Construction of an overhead water tank at Raska Village at a total cost of ₹9.50 lakhs
 - ✓ Company has contributed ₹60 lakhs for part fencing along SUNR-PPSP section to safe guard the lives of Asiatic Lions.
 - ✓ Further, in association with GPPL, company has constructed an approach road in Rampara Village at an estimated cost of ₹28 lakhs.

The remaining amount has since been carried forward in FY 2015-16.

FY 2015-16, Company has allocated an amount of ₹1.48 crore for various identified CSR activities such as: -

- ✓ ₹1.25 crore for Project Raska (includes construction of bio-toilets, construction of community hall, internal roads, health care, etc.,). 100 bio-toilets have already been completed and handed over to the Users in August 2016. Community centre, constructed at a cost of ₹50 lakhs have been handed over to Raska Panchayat on 29th September 2017.
- ✓ Child care project in Guwahati ₹40 lakhs
- ✓ Girl child education & vocational training in Allahabad ₹25 lakhs
- ✓ Primary education – CHETNA Project, Delhi for ₹3.30 lakhs

For FY 2016-17, Company has allocated an amount of ₹1.50 crore for various identified ongoing CSR activities such as: -

- ✓ Girl child education & vocational training in Allahabad ₹3 lakhs.
- ✓ Setting up Day Care facility for rehabilitation and reintegration of persons suffering from chronic mental illness and emotional disturbances into their families and society, Lucknow with a budget of ₹10 lakhs.

For FY 2017-18, Company has allocated an amount of ₹1.66 crore for various identified ongoing CSR activities such as: -

- ✓ Raska School Development works ₹13 lakhs
- ✓ Setting up Day Care facility for rehabilitation and reintegration of persons suffering from chronic mental illness and emotional disturbances into their families and society, Lucknow with a budget of ₹19 lakhs.
- ✓ ₹55 lakhs for ongoing and various other CSR projects.

- ✓ Primary education – CHETNA Project, Delhi for ₹7 lakhs (Project was up to Oct.2017).
- ✓ ₹10 lakhs for Railway Bhavnagar School.
- ✓ Training and Administrative expenses ₹8 lakhs.

For FY 2018 - 19, Company has allocated an amount of ₹1.73 crore for various identified ongoing CSR activities such as: -

- ✓ Girl child education & vocational training in Allahabad ₹67.58 lakhs. The Project was up to 31st March 2019.
- ✓ Raska Development works ₹35 lakhs
- ✓ Setting up Day Care facility for rehabilitation and reintegration of persons suffering from chronic mental illness and emotional disturbances into their families and society, Lucknow with a budget of ₹20 lakhs. The Project was up to 31st March 2019
- ✓ ₹11 lakhs for ongoing project at Guwahati for street children; the project was up to 30th September 2018.
- ✓ Training and Administrative expenses ₹8.75 lakhs and another ₹8.75 lakhs for project contingency.
- ✓ Balance to be allotted ₹20 lakhs.

For FY 2019 - 20, Company has allocated an amount of ₹1.71 crore for various identified ongoing CSR activities such as: -

- ✓ An amount of ₹1.38 crore towards construction of a check dam in Uchhaiya Village. Project is expected to be completed by 31st March 2020.
- ✓ An amount of ₹26.4 lakhs towards solar street lighting Project in Chatadiya and Ningala No.1. The Project is completed on 14th August 2019.
- ✓ Training and Administrative expenses ₹8.65 lakhs

- ✓ Balance remaining to be allocated is approx. ₹80 lakhs
