- 7. The tender shall be awarded based on the highest offer received for GI Sheet and other Iron scrap. Up on award of the contract, the particular highest bidder shall deposit full amount by way of Demand Draft/Pay Order in favour of "Pipavav Railway Corporation Limited" payable at New Delhi of the scrap item within 3 days. And deposited EMD with tender will be kept as Security Deposit which shall be returned to the party without any interest up on successful completion of the lifting of the items or within 60 days whichever is earlier.
- 8. It may be noted that the quantity as mentioned in tender shall be considered as approximate quantity but the actual payment would be calculated on the basis of actual quantity of scrap to be lifted. In case the actual quantity is above the quantity mentioned in tender, then the balance amount has to be paid through PRCL' QR Code Scanner or any mode online payment and if less the quantity mentioned above tender, then the balance amount will be returned by PRCL with Security Deposit in form of NEFT/RTGS in account of tenderer as per details provided in Technical Bid
- 9. The truck/tempo for Scrap lifting and carrying shall be arranged by tenderer at their own cost. The tenderer shall have to make arrangement for loading of scrap to truck/ tempo at their own cost and PRCL will not pay any charges for the same.
- 10. Prior to the loading of scrap on the Truck/Tempo, the empty Truck/Tempo shall be taken to the Weighing Bridge for weighing in presence of representative from PRCL.
- 11. The loaded truck would again be sent to the weighing scale for weighing, and the weight of material would be calculated for payment of quantity of scrap based on the quoted price. The Weighing Bridge will be decided at random by PRCL representative and the weighing bridge charges (if any) shall be borne by the H1 bidder.
- 12. All process of disposal of scrap material including weighment shall be in present of authorized / nominated representative of PRCL, who shall certify to the effect of completion of such process of scrap sale.
- 13. Photo/videography of the site before and after completion of scrap shall be taken.
